

The meeting was held at the Marina Del Rey, 1 Marina Drive Bronx, NY 10465 and began at 10:17am. President Dyer introduced Jimmy Warden, NAPS National Secretary Treasurer. Jimmy spoke on the following topics:

- Paytalks (we are waiting for the NALC to finish their negotiations and then we have 45 days)
- Relief Supervisor positions.

Dee Perez, NAPS New York Area VP was introduced. He spoke on several topics:

- 1. The membership Blitz began on 9/13 through 10/15 as a friendly reminder. As a friendly reminder when you send in your 1187 through join@naps.org include me in the email.
- 2. Currently, according to my calculations, the NY Area membership is at 91.90% but with the DCO being behind a couple of months this is why you see our percentage in the low 80%.
- 3. The number one branch in signed members in FY 23 is Branch 202 with 45 and Branch 100 is second with 41.
- 4. The NY Area has 543 non-members according to the DCO non-members July report. Based on the current July dues being paid these equals \$146,388.00 that is waiting to be collected. In terms of votes, this equals 54 votes the NY Area doesn't have.
- 5. The NY Area according to the July DCO has 450 non-members that are level 17 this equals 82.87% of the total non-members.
- 6. New Members
 - How about inviting non-members to a meeting and how you are going to make this happen?
 - How about offering KSA career-building classes for your current members if they wish to move up in the service?
 - How about inviting someone from your District to do a Triangulation demonstration and a deep dive into locating last-mile letters and flat failures? And how to write the Triangulation report prior to 8:30 AM daily.



Ms. Trich Schmidt Acting Manager Labor Relations New York City was introduced, and she spoke on the following:
